 and obtain the CITY'S approval of the accounting procedures and records to be utilized by the
 CONTRACTOR on the Project. CONTRACTOR shall preserve the aforementioned Project
 records for a period of ten (10) years after final payment, or for such longer period as may be
 required by law.
- The CITY is a public agency subject to Chapter 119, Florida Statutes. The CONTRACTOR shall comply with Florida's Public Records Law. Specifically, the CONTRACTOR shall:
 - Keep and maintain public records that ordinarily and necessarily would be required by the CITY in order to perform the service;
 - B. Provide the public with access to such public records on the same terms and conditions that the CITY would provide the records and at a cost that does not exceed that provided in chapter 119, FS, or as otherwise provided by law;
 - C. Ensure that public records that are exempt or that are confidential and exempt from public record requirements are not disclosed except as authorized by law;
 - D. Meet all requirements for retaining public records and transfer to the CITY, at no cost, all public records in possession of the CONTRACTOR upon termination of the Agreement and destroy any duplicate public records that are exempt or confidential and exempt. All records stored electronically must be provided to the CITY in a format that is compatible with the information technology systems of the agency.

The failure of CONTRACTOR to comply with the provisions in the Article shall constitute a default and breach of this Contract.
