  - Approved. Food trucks are used for mitigation in the roadway.
  - PD may be required for this event based on the expected crowd size.
- Fire:
  - Approved. With the condition that all food and trucks must be inspected, approved, and have a current City of Clearwater food truck inspection decal prior to event.
  - Spacing between food trucks must be minimum of 10ft.
  - Event coordinator is responsible to confirm with food truck owner that all fire protection components are present at the event with current inspection tags. (Fire Suppression System, Hood Cleaning, and Fire Extinguishers)
- CRA:
  - Approved. You are eligible for the DDB funding.
- Special Events/Parks and Rec:
  - Approved. Please check with Fire if tents are potentially going to be a concern in the fire lane areas.
  - Vendor setup "within the vendor plaza" or the footprint of the BayCare Sound is tentatively denied.
  - Approval from REH is required.
  - You will need to resubmit site map and change the location of the stage and generators should not be placed in flower beds.
  - As a reminder driving on the green is prohibited.
  - Estimated Parks & Recreation fees: App fee (\$50); Venue fee, Green, Lower plaza, Cleveland St ext, and Baywalk Promenade - \$1250.00 per day.
    - Setup day fees will apply and ESS fees for access and monitoring usage.
