

Dear Commissioner Flowers,

I will be brief, knowing your time is valuable. I am writing in strong support of the Philadelphia Phillies and their request for TDT funding to expand and improve BayCare Ballpark. Having sat in your seat, I understand the challenge of distributing limited resources, and you know I value prudent, conservative decision-making. At the same time, I also recognize that transformative, long-term projects seldom come along. My father used to say, *"Quality remains long after the price is forgotten."* I believe this applies both to this project and to the partnership it represents.

Importantly, this request does not draw from your general fund but from TDT dollars—many of which are generated in Clearwater for the benefit of the entire county.

The Phillies' relationship with Pinellas County and the City of Clearwater spans more than 70 years, and their commitment has gone far beyond baseball. They have given back to hundreds of local charities, and most recently, after the devastating 2024 hurricanes, they contributed an extraordinary \$1,000,000 in relief aid—an act no one would have expected, yet one entirely consistent with their history as a partner.

Others will no doubt provide you with extensive data on the Phillies' economic and cultural contributions. Instead, I want to highlight two points you may not hear elsewhere:

1. **Connectivity with Philadelphia.** Tampa International Airport now hosts 11 direct daily flights to and from Philadelphia. This is no coincidence—it reflects a 73-year bond between our regions.
2. **Catalyst for redevelopment.** John Middleton's purchase of the property south of the stadium offers nearly one million square feet of potential mixed-use development. This aligns with the US-19 redevelopment plan and promises significant long-term revenue for the County, schools, and the City. Such private investment should be recognized and supported.

As Commissioners, you hold the final word. I urge you to take a long-term view of this opportunity—not just as an investment in a facility, but as a reinforcement of a partnership that continues to strengthen our community and economy.

As the three-time former Mayor of the City of Clearwater I feel well positioned to share my knowledge on the importance that the presence of the Philadelphia Phillies have in Clearwater and Pinellas County. For 79 years Phillies Spring Training has been and continues to be a highly anticipated experience in Clearwater for both locals and out-of-county visitors alike. The family friendly environment provided by the Phillies at the Carpenter Complex and BayCare Ballpark attracts between 135,000 to 150,000 visitors per year, 81 % of which come from 50+ miles from Pinellas County.

I know you have been presented with an impressive and very accurate array of financial reports that highlight the economic impact on our area that the Phillies provide annually so I will not rehash that information here. What I will share is some of the ancillary benefits that many people don't realize when it comes to the Phillies being in Clearwater.

In 1988 I was approached about a position in the cable tv business in Clearwater. When I was told I could have a professional relationship with the organization and could be involved in cable casting their spring training and minor league games that was the determining factor in my tough decision to leave my childhood hometown and move here.
