RESOLUTION NO. 2018- 147

A RESOLUTION APPROVING THE RENEWAL OF AN AGREEMENT BETWEEN THE CITY OF TAMPA AND QUALITY ROOFING, INC. FOR THE PROVISION OF ROOFING SERVICES IN THE ESTIMATED AMOUNT OF \$3,127,953 FOR USE BY THE LOGISTICS & ASSET MANAGEMENT DEPARTMENT/FACILITY MANAGEMENT DIVISION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Tampa, Florida, by authority contained in Resolution No. 2016-139, passed and adopted by City Council on February 18, 2016, entered into an Agreement with Quality Roofing, Inc. for the provision of Roofing Services for use by the Logistics & Asset Management Department/Facility Management Division; and

WHEREAS, said Agreement provided for renewal under the same terms and conditions as contained therein when mutually agreeable to the parties, and the parties have mutually agreed to such extension.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA:

Section 1. That, pursuant to Resolution No. 2016-139, passed and adopted by the City Council on February 18, 2016, the City of Tampa is renewing the Agreement with Quality Roofing, Inc. for an additional two-year period commencing at 12:01 a.m., February 18, 2018 and expiring at 12:00 midnight, February 17, 2020 upon the same terms and conditions as contained in the original Agreement.

Section 2. This will provide \$1,042,651 in FY2018, \$1,563,977 in FY2019 and \$521,325 in FY2020, subject to annual appropriation, for the provision of Roofing Services for use by the Logistics & Asset Management Department/Facility Management Division, and shall be controlled by requisition.

Section 3. That other proper officers of the City of Tampa are authorized to do all things necessary and proper in order to carry out and make effective the provisions of this Resolution, which shall take effect immediately upon its adoption.
