## INTRODUCTION




Figure 1. Proposed Project Area, 2024 Clearwater, FL Topographic Quadrangle, scale 1:24000.

The purpose of this desktop assessment was to determine the probability of encountering cultural resources within the proposed project area (Approx. 11.75 acres) and to determine potential effects to cultural resources listed in or eligible to be listed in the National Register of Historic Places (NRHP). The project area consists of two contiguous parcels (identified as Pinellas County Parcel ID Nos. 03-29-15-85428-000-0030 & 03-29-15-00000-430-0500) located along the southern central boundary of Section 03 Township 29S Range 15E (**Figure 1**). An extant fire department building is located within the eastern portion of the project area. Historically, the project area consisted of a junkyard and used car lot within the eastern portion, and undeveloped uplands surrounding an unnamed surface water with small a tributary, flowing north from Stevenson Creek.

**This desktop-based assessment is being conducted for due diligence purposes only and does not meet the requirements for a Phase I Cultural Resource Assessment Survey (CRAS).** No field investigations were conducted as part of this assessment. Cultural resource desk-based assessments provide developers, planners, and agency reviewers known information about a tract for proposed development, including previously conducted surveys, previously mapped cultural resources within and adjacent to the project area, and the probability of encountering cultural resources within the project area.

The term “cultural resources” as used herein refers to archaeological sites and/or historical architectural resources, structures, or objects. Archaeological site location information is classified as sensitive, please limit the distribution of this information to pertinent personnel.

## 1.0 PROJECT SETTING

The project area falls within Pinellas Peninsula subdistrict of the Southwestern Flatwoods District within the Florida Section. The Pinellas Peninsula subdistrict is characterized as a cusped foreland between the Middle Miocene recent clastic sediments southward along the coast and limestone coast to the north. Sand and shell from the Plio-Pleistocene underlies the lower terraces; with residual, deeply weathered sand hills occur in the northern portion of the peninsula. The Southwestern Flatwoods District provincial sedimentary rocks and sediments date to the Miocene and Pliocene. Quaternary deposits are thin to nonexistent (Brooks 1981).

According to the United States Geological Survey (USGS) Natural Resources Conservation Service (NRCS), the soils within the project boundaries are mapped as very poorly drained to poorly drained (**Figure 2**). The nearest surface water is Stevenson Creek which intersects the southwestern corner of the project area. Stevenson Creek flows southeast and south from its confluence with Clearwater Harbor, situated within the Gulf. Based on the most recent aerial imagery, the project area consists of surface waters surrounded by wetlands, densely vegetated uplands, disturbed graded area associated with former junk yard, with a fire station and associated parking lot in the eastern corner (**Figure 3**). Elevation across the project area ranges from sea level to 6.4 meters (21 feet) above mean sea level, sloping upwards to the north and east.

## STATE SITE FILE DATA REVIEW

Terracon conducted a search of the Florida Master Site File (FMSF) database, updated July 2025, to determine whether the project area has been previously subjected to cultural resource investigations or whether cultural resources have previously been recorded within the project area. FMSF data indicated that four previous cultural resource investigations (FMSF Survey Nos. 2827, 16115, 25403 & 27632) intersected the current project area in its entirety. Additionally, no cultural resources have been previously recorded within the project area. Based on available information from previously conducted investigations, no subsurface archaeological testing has been performed within the proposed project area.

Expanding the search to include a one-mile (1.61-kilometer) radius surrounding the project area indicates ten cultural resource surveys have been conducted surrounding the project area (**Table 1; Figure 2**). In addition, 500 historic structures, six (6) historical bridges, two (2) resource groups, one (1) historical cemetery, one (1) NRHP listed resources, and six (6) archaeological sites have been previously recorded within a one-mile radius (**Table 2; Figure 3**). Due to the extensive nature of previously recorded structures within a one-mile (1.61 kilometer) radius of the project area, please refer to **Appendix A** of this assessment for a complete list of these resources.

Five hundred (500) structures have been previously recorded, of which: two (2) are eligible for inclusion on the NRHP, 266 are ineligible for inclusion on the NRHP, one (1) had insufficient information provided

to evaluate at the time of the previous survey, and 231 structures have not been evaluated by the SHPO.


Survey No. 2827 was a county-wide historic and archaeological resource survey of unincorporated areas of Pinellas County conducted in 1991, prior to the adoption of modern testing regulations developed by the Florida Division of Historical Resources in Module 3 (2002). The survey collected and analyzed a site inventory to establish zone of archaeological probability for the county. Limited field testing was conducted to determine the accuracy of the predictability model, no subsurface testing investigation was conducted within the project area (Piper Archaeological Research, Inc 1991).

Survey No. 16115 was an additional cultural resource inventory of Pinellas County conducted in 2008. Zones of archaeological probability for various temporal periods were calculated based on previously recorded cultural resources to develop county historic preservation laws. No subsurface investigations were conducted in conjunction with this survey (New South Associates 2008).


Survey No. 25403 was a historic bridge survey of Pinellas County conducted by architectural historians with no archaeological methodology utilized or cultural resources recorded within the project area (Cardno ENTRIX 2018).

Survey No. 27632 intersected the project area and was county wide survey evaluating flood hazard areas with above ground mid-century historic resources. No resources were identified within the project area during the survey, and no subsurface archaeological methodology was utilized (University of Florida 2021).

Historic structure No. PI08347 (North Ward School) was listed on the NRHP on September 9, 2021, and is located approximately 1.27 kilometers (0.79 miles) southwest of the project area. The structure was built in 1921 with its period of significance spanning from 1915 to 1971.

## 2.0 COUNTY PROPERTY APPRAISER’S DATABASE REVIEW

The Pinellas County Property Appraiser database was examined to identify whether known historic-age structures (50 years or older) not previously recorded within the FMSF are present within the project area or on adjacent parcels. In total, twenty-seven (27) unlisted structures were identified on the Pinellas County property appraiser, a summary of these findings is found below in **Table 3**.

### 3.0 HISTORICAL MAP AND AERIAL REVIEW

Historical period maps and aerial photographs of the project area were examined to gain a better understanding of historical land use and development in the region and to assess the potential for historic period resources within the Area of Potential Effects (APE), which is defined in 36 CFR Part 800.16(d) as “the geographical area or areas within which an undertaking may cause changes in the character or use of historic properties if, such properties exist.” For the purposes of this desktop, the APE is one mile surrounding the project boundaries.




Figure 4. 1872 GLO Survey Plat Depicting Twp 45 S Range 33 E.

Maps consulted during this analysis include the General Land Office (GLO) 1872 Survey Plat depicting Township 45 S, Range 33 E; the 1921 *Sand Key, Florida* and 1974 (1976 edition) *Clearwater, Florida* United States Geological Survey (USGS) topographic quadrangles; and United States Department of Agriculture (USDA) historic aerial imagery from 1942 and 1971 of Pinellas County (**Figures 4–6**). The results of the historic map and aerial review are summarized in **Table 4**.

1974 (1976 edition) <i>Clearwater, FL</i> topographic quadrangle	No discernible development was depicted within the project area or on adjacent parcels. Significant development associated with urban sprawl was depicted as red areas due to rapid development.




Figure 5. 1921 Sand Key, FL Topographic Quadrangle, scale 1:62,500.




Figure 8. 1974 (1976 edition) Clearwater, FL topographic quadrangle, scale 1:24,000.

## 4.0 CONCLUSION

In summary, four cultural resource surveys, with no subsurface investigation components, were previously conducted within the project area boundaries. No cultural resources have been previously documented within the project area. Additionally, nine cultural resource surveys have been conducted within a one-mile radius of the proposed project area. The previous cultural resource surveys documented 500 historic structures, six (6) historical bridges, two (2) resource groups, one (1) historical cemetery, one (1) NRHP listed resource, and six (6) archaeological sites within a one-mile radius.

The 1872 GLO survey plat map depicted the project area as undeveloped land with a creek running north to southeast within the western section. The USGS 1921 *Sand Key, Florida* topographic quadrangle depicted a road running north to south within the interior eastern section. The 1942 USDA aerial photograph depicted no discernible development within the project area and on adjacent parcels. By the 1971 USDA aerial photograph, the eastern portion of the project area was depicted as car lot and junkyard. The western portion adjacent to Stephenson Creek remained undeveloped. Significant development on adjacent parcels was depicted. No discernible changes in development within the project area or on adjacent parcels were depicted within the 1974 (1976 edition) *Clearwater, Florida* topographic quadrangle.

Based on criteria established in the State of Florida’s Module 3 guidelines for Historic Preservation Professionals there is a **moderate probability for encountering intact precontact cultural resources within the project area**. This is supported by distance to fresh water sources, substantial prior development within the project area, elevation and soil drainage. Based on the review of historic period maps which depicted the presence of structures on adjacent parcels within the viewshed of the

project area, unlisted historic age structures identified on the Pinellas County property appraiser, there is a **high probability for encountering historic period cultural resources on adjacent parcels within the project area viewshed.**

**As federal funding, in the form of an Environmental Protection Agency (EPA) Brownfield Assessment grant exists for the project, compliance with Section 106 of the National Historic Preservation Act (NHPA) will to be required. A Section 106 Review or other State specific compliance requirements (ERP permitting) would also likely include a cultural resource assessment survey and/or archaeological monitoring of the project area and consideration of the viewshed of historical resources on adjacent parcels.**

**As no subsurface archaeological testing has been conducted within the project area, it is likely a CRAS and/or archaeological monitoring may be required if Brownfield assessment activities have the potential to cause effect.** An example of Brownfield assessment activities that may effect cultural resources include soil excavation, capping or covering of contaminated soil and test pitting (areas of former subsurface tanks may be excluded).

A cultural resource assessment survey would include an archaeological and historic architectural survey of the project area and a defined area of potential effect which may extend onto adjacent parcels. **Due to the high probability for encountering historic resources on adjacent parcels and the absence of archaeological subsurface survey within the project area, it is likely that the SHPO will request a CRAS for the project area if brownfield activities have the potential to cause effect.**
