

#### SECTION 07, TOWNSHIP 29 SOUTH, RANGE 16 EAST DESCRIPTION

A parcel of land located in the Southwest 1/4 of the Northeast 1/4 of Section 7, Township 29 South, Range 16 East, Pinellas County, Florida, being a portion of that certain parcel described in Official Records Book 3583, Page 142, public records of said County, and being described as follows:

COMMENCE at the Southeast corner of said Southwest 1/4 of the Northeast 1/4 of Section 7; thence run N89'59'29"W along the South line of said Southwest 1/4, for a distance of 118.31 feet to a point on the Southwest right-of-way line of old Coachman Road (County Road 535, formerly County Road 32) also being the POINT OF BEGINNING: thence continue N89'59'29"W along said South line, for a distance of 5.43 feet: thence N30'59'41"W for a distance of 28.22 feet; thence N48'53'53"W for a distance of 42.94 feet; thence N10°36'02"W for a distance of 37.88 feet; thence N32°42'06"W for a distance of 21.61 feet; thence N49°35'16"W for a distance of 62.14 feet; thence S69°37'34"W for a distance of 9.63 feet; thence N35'54'33"W for a distance of 66.73 feet; thence N48'13'07"W for a distance of 92.29 feet to the aforementioned Southwest right-of-way line of Old Coachman Road, and a non-tangent curve to the right, at which point a radial line bears N32'42'49"E; thence Southeasterly along said right-of-way line, for a distance of 355.00 feet along the arc of said curve, being concave to the southwest, having a radius of 670.00 feet, central angle of 30°21'30", chord bearing of \$42°06'26"E, and chord length of 350.86 feet, to the POINT OF BEGINNING.

CONTAINING: 3,145 square feet or 0.072 acres, more or less.

Bearings and distances are referenced to the West Zone of the Florida State Plane Coordinate System, North American Datum of 1983, 1990 adjustment, according to the Specific Purpose Survey of Right of Way for Old Coachman Road and N.E. Coachman Road, certified by William H. Fulghum of Volkert, Inc., on June 18, 2015 (Pinellas County Survey File Number 1957).
