

ORDINANCE NO. 9093-18

AN ORDINANCE OF THE CITY OF CLEARWATER, FLORIDA, AMENDING THE ZONING ATLAS OF THE CITY BY REZONING A 7.548-ACRE PORTION OF CERTAIN REAL PROPERTY LOCATED ON THE EAST SIDE OF OLD COACHMAN ROAD APPROXIMATELY 2,370 FEET NORTH OF DREW STREET, WHOSE POST OFFICE ADDRESS IS 1005 OLD COACHMAN ROAD, CLEARWATER, FLORIDA 33765, FROM OPEN SPACE/RECREATION (OS/R) TO INSTITUTIONAL (I); PROVIDING AN EFFECTIVE DATE.

WHEREAS, the amendment to the Zoning Atlas of the City as set forth in this ordinance is found to be reasonable, proper and appropriate, and is consistent with the City's Comprehensive Plan; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLEARWATER, FLORIDA:

Section 1. The following described property in Clearwater, Florida, is hereby rezoned, and the Zoning Atlas of the City is amended as follows:

Section 2. The City Engineer is directed to revise the Zoning Atlas of the City in accordance with the foregoing amendment.

Section 3. This ordinance shall take effect immediately upon adoption, subject to the approval of the land use designation set forth in Ordinance 9092-18 by the Pinellas County Board of County Commissioners.

A PARCEL OF LAND BEING A PORTION OF THOSE LANDS DESCRIBED IN OFFICIAL RECORDS BOOK 3642, PAGE 416 OF THE PUBLIC RECORDS OF PINELLAS COUNTY, FLORIDA LYING IN SECTION 7, TOWNSHIP 29 SOUTH, RANGE 16 EAST, PINELLAS COUNTY, FLORIDA BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

START AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 29 SOUTH, RANGE 16 EAST AND RUN N 89° 59' 16" W, 120.02 FEET ALONG THE EAST-WEST CENTERLINE OF AFORESAID SECTION, TO THE WESTERN BOUNDARY LINE OF U. S. HIGHWAY 19 (S.R. 55) FOR A POINT OF BEGINNING; THENCE CONTINUE N 89° 59' 16" W, 382.67; THENCE RUN N 0° 0' 25" E, 253.08 FEET; THENCE RUN N 89° 59' 35" W, 251.53 FEET; THENCE RUN S 0° 0' 25" W, 139.91 FEET; THENCE RUN S 79° 36' 57" W, 355.38 FEET; THENCE RUN N 0° 43' 32" E, 435.02 FEET TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF TAMPA AND GULF COAST RAILWAY (S.C.L.); THENCE RUN S 81° 06' 44" E ALONG SAID SOUTH RIGHT OF WAY LINE 995.46 FEET TO THE WEST BOUNDARY LINE OF U.S. HIGHWAY 19 (S.R. 55); THENCE RUN S 0° 54' 46" W ALONG SAID WEST BOUNDARY LINE 330.45 FEET TO THE POINT OF BEGINNING.



COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHEAST 1/4 OF SECTION 7, TOWNSHIP 29 SOUTH, RANGE 16 EAST, PINELLAS COUNTY, FLORIDA; THENCE NORTH 89°59'16" WEST, ALONG THE EAST-WEST CENTERLINE OF SAID SECTION 7, 956.39 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 28°28'16" WEST, A DISTANCE OF 250.10 FEET; THENCE NORTH 59°36'32" WEST, A DISTANCE OF 39.28 FEET; THENCE NORTH 01°27'56" EAST, A DISTANCE OF 200.08 FEET TO AFORESAID EAST-WEST CENTERLINE OF SECTION 7; THENCE SOUTH 89°59'16" EAST, ALONG SAID EAST-WEST CENTERLINE, A DISTANCE OF 147.99 FEET TO THE POINT OF BEGINNING.
