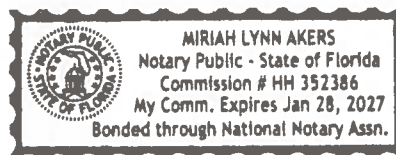

Procedure for Receiving and Responding to Service Calls

We are informed of the City of Tampa's roofing service requests in several ways and our management staff has extensive communication processes in place for prompt and efficient service responses.

We typically receive emails from the DPW system alerting us that a work order has been issued. These emails are copied to three individuals within our company. Having multiple Quality Roofing team members receive these emails enables our prompt response and ensures that work orders do not go unnoticed. Email alerts are linked to cell phones so work orders can be acted upon regardless of when they are received.

Our secondary procedure is to check WEBTMA on a daily basis to see if any work orders have been entered into the system to which an email alert was not set.

We also have direct contact with DPW personnel to inform us that our services are required and in what capacity.

Once we receive notice that a work order has been issued, we create a work order in our Acculynx system. Scheduling is based upon the priority level assigned by DPW, on a scale of 1 to 5 with Level 1 being critical and Level 5 being routine or preventive maintenance. Our response time correlates to the importance the City designates to the work order.

A Priority Level 1 (Critical) work order is considered serious and arrangements are made to dispatch a crew directly from the shop or to redirect a crew already in the field to address the work order on the same day it is received. If the crew is unable to perform permanent repairs (i.e. due to weather), all attempts are made to provide a temporary solution until a more substantial repair can be implemented.

A Priority Level 2 (Urgent) work order is considered serious, and arrangements are made to dispatch a crew directly from the shop or to redirect a crew already in the field to address the work order on the same day it is received. If the crew is unable to perform a permanent repair (i.e. due to weather), all attempts are made to provide a temporary solution until a more substantial solution can be implemented.

Priority Level 3 (Normal) and Level 4 (Low) are considered less crucial and are dispatched as our normal schedule allows, usually within the same work week.

Priority Level 5 is routine preventive maintenance and includes recurring jobs that are automatically dispatched at set intervals. These are considered low priority as they do not constitute active leaks. Active leaks are given priority to avoid or minimize property damage.

For the Critical and Urgent work orders, our GPS equipped service vehicles allow us to identify the closest field worker and dispatch them immediately to the scene. On call employees can be mobilized as needed to address high priority work orders received after normal business hours and on weekends. For this purpose, we ensure that at least one man per team is equipped with a mobile device for instant communication.

Upon receiving a work order and assessing the priority level, the job is scheduled and a service crew assigned. Our service technicians work in pairs out of concern for safety, but they may be combined as necessary to satisfy a given scope of work.

Service crews are informed on the nature of the work order and we discuss the methods and materials to be used in its completion. After arrival, our service technicians check in with the appropriate city personnel to inform them of their presence and the reason for their visit. Interior damage, if any, is noted and photographed. Technicians may remove ceiling tiles, access crawl spaces and attics, and employ other means to identify the cause and extent of active leaks.

Once the issue is identified, it is noted and photographed, repairs are performed and the jobsite cleaned of all construction waste. Photographs are taken during and after the finished repair or other scope of work. Service technicians are required to provide written paperwork detailing time spent, materials used and a description of work performed. Time is calculated port to port and a half hour lunch break is deducted from jobs six hours or more in duration. Work orders are processed, and time and material computed by means of a customized Excel spreadsheet. The work order is closed out in WEBTMA by entering the time and date of completion. The appropriate supporting documents and photos are assembled, and the billing package is passed to our accounting department for invoicing.



Hiring Procedures

I. Purpose

The purpose of this policy is to establish guidelines for the employment process and to assure that the recruitment and selection processes are consistent and identify the best qualified employees for Quality Roofing, Inc.

II. Policy

Quality Roofing, Inc. is an equal opportunity employer and seeks to employ individuals based upon their qualifications, experience, and ability to perform the position responsibilities. All applicants can expect a fair and completed evaluation of their application.

III. Primary Source of Recruitment

Primary Source of Recruitment are referrals, word of mouth, and advertisements on company vehicles. When needed, Quality Roofing, Inc. advertises available positions externally on job recruiting websites and on other online or print platforms.

IV. Personnel Hiring Procedures

The Department Manager shall notify the Human Resources Department of all vacancies and may, within the provisions of this policy, recommend promoting a qualified employee within the department, or posting the position externally on a job recruiting website.

The Department Manager and the Human Resources Department will screen applications and resumes prior to scheduling interviews. Initial interviews are generally conducted by the Human Resources Department, then followed up with a second interview with the Department Manager. Team interviews may be conducted as needed for some positions. The Department Manager or the Human Resources Department have the authority to make the hiring decision. The Department Manager and the Human Resources Department use interview checklists and predetermined screening questions and record all interviews conducted. All applications and resumes of applicants not selected are recorded by the Human Resources Department for record keeping purposes.

Screening Procedures

Reference checks: After a decision has been made to hire a particular candidate, the Human Resources Department may check references for the candidate.

Criminal Background Checks: Quality Roofing, Inc. is compliant with 'Ban the Box' requirements, meaning that we voluntarily comply with omitting inquiries on our employment application that regard to an applicant's criminal history during the screening process. We refrain from asking applicants about their criminal history, and we do not conduct a background check until after a conditional offer of employment has been sent to the applicant.

Pre-Employment Drug Screens: The Human Resources Department will contact final candidates to complete a pre-employment drug screen. Quality Roofing, Inc. is a Drug-Free Workplace and has a policy in place indicating that process.

E-Verify: If needed, Quality Roofing, Inc. has access to use E-Verify as an Internet-based system that compares information from an employee's Form I-9, Employment Eligibility Verification, to data from U.S. Department of Homeland Security and Social Security Administration records to confirm employment eligibility.

Job Offer

If the Human Resources Department receives satisfactory results from the reference checks, criminal background check, and the pre-employment drug screen, it or the Department Manager will notify the candidate to confirm the job offer.

Initial Start Date and Orientation

On an employee's start date, the new employee's Department Manager is responsible for providing a department orientation for the new employee and coordinating with the Safety Director to perform needed safety training.

The employee's Supervisor will review department policies and procedures and if needed the Human Resources Department will review Quality Roofing, Inc. Employee Handbook.

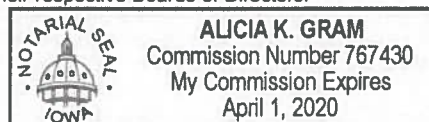
