Mayor and Council members:

I am submitting this questionnaire for each of you to consider me for interim council member to fill the vacancy of Council member Doreen Caudell's seat. I hope you will view me as a viable candidate for this interim position to contribute in the collective determination of our City's future in the coming years:

1. What is your understanding of the Council's duties and responsibilities?

Under Clearwater's form of government, the City Council is similar to the board of directors of a company. It sets policies and approves the City's budget. The City Manager essentially reports to the Council and administers policies established by the Council and the everyday activities of the City. The Council also establishes tax rates, approves code variances and annexations, reviews and approves large City contracts. Since the City Manager and City Attorney report to the Council, the Council is also charged with the performance evaluation of these two individuals.

2. Have you ever observed a Council meeting either in person or on C-View, the City's TV station?

Yes, I have attended and spoke at many City Council Meetings and regularly watch meetings on C-View.

3. What background and/or qualifications do you have that you feel would qualify you to serve on the Council?

- President of GTE Leasing Company (VP GM of Verizon Credit Corp merger with GTE/Bell Atlantic).
- Vice President of Sales and Marketing of Progress Telecom, a wholesale broadband and wireless infrastructure company of Progress Energy 2000 -2002
- Exec VP/COO Clearwater Marine Aquarium 2008 - present
- Served as a member of the Marine Advisory Board for the City from 2004 – 2008
- Graduate of Clearwater's Citizen's Academy.
- Former member of the Citizens Advisory Committee 2005 to review of the City's Comprehensive Plan.

- Member of the Community Development Board for 8 years (Chairman in 2016)
- Served on the Pinellas County Boating Access Task Force 2005
- Board Member of the Clearwater Region Chamber of Commerce 2009 to present (member of the Public Policy and Transportation Committee)
- Board member Clearwater Downtown Partnership 2012 - 2018
- Jolley Trolley Board member 2010 – 2012 (Chairman 2012)
- Board member of the Clearwater Beach Chamber of Commerce (Chairman 2016)
- Island Estates Civic Association Board of Directors 2003 – 2006 (President '05 – '06)

4. Why do you want to serve as an Interim Councilmember?

I consider myself to have a good understanding of our city government and its departments and have a good working relationship with many City staff members.

I believe our City is in a transition to where it can become one of the greatest cities in the State of Florida. We are on the cusp of determining the best way to revitalize our City's Core and I would like contribute to the formulation of this transformation during the next two years as the decisions made will set the stage for the City's future for decades into the future. We are also determining how to best redevelop other areas of the City and formulate it's transportation needs. My background on the transportation committee for the Clearwater Regional Chamber of Commerce helps me to understand the complexities of the challenge to improve transportation alternatives for the future.

I hope you will find the above information worthy of your consideration for this interim position. If selected, it would not be my intention not to run for a City Council position in 2020 but is a path for me to contribute and be a part of the City's future.

I am writing to recommend Rebecca Tieder for the vacancy on the Clearwater City Council.


