THIS COMPLAINT FOR ABATEMENT OF NUISANCE is made pursuant to Sections 20.01 through 20.04, Clearwater Code of Ordinances, and as authorized by Section 893.138, Florida Statutes, to provide you written notice that the Petitioner herein, City of Clearwater, has reason to believe and does believe that conduct constituting a public nuisance has occurred at the above described premises, to wit:

AMENDED COMPLAINT

This action involves the property located at 207 Pennsylvania Avenue, Clearwater, FL; hereinafter referred to as "Premises." The Premises is a single-family dwelling, that is being utilized in violation of Section 20.02(5), Clearwater Code of Ordinances. All heirs of Josephine Dixon, owner of record, will hereinafter be referred to as "Respondents."

- 1. On June 1, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 2. On June 1, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 3. On June 2, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 4. On June 6, 2022, Detectives from the Clearwater Police Department purchased cocaine from the residence.
- 5. On June 13, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 6. On June 20, 2022, Detectives from the Clearwater Police Department purchased cocaine from the residence.
- 8 On July 11, 2022, Detectives from the Clearwater Police Department served a search warrant resulting in the seizure of methamphetamine, marijuana, cocaine, MDMA and drug paraphernalia used in the sale of drugs.

All drugs seized during the execution of the search warrant were tested using field presumptive tests and the results of said presumptive tests were positive for methamphetamine, marijuana, cocaine and MDMA. The narcotics were sent to the Pinellas County Forensic Laboratory for further testing.

As a result of the search warrant the following people have been charged with crimes:

Jamayn Johnson was arrested and charged with Trafficking MDMA, Sale & Possession of Crack Cocaine within 1,000 ft. of a School, Possession of Oxycodone, Principle to the Sale of Crack Cocaine, Unlawful Use of a Two-Way Communication Device and Operating a Drug House.

Jamar Johnson was arrested and charged with Felon in Possession of a Weapon, Sale & Possession of Crack Cocaine within 1,000 ft. of a School and Operating a Drug House.

Carlton Brye is at large but has been charged with three counts of sale & Possession of Crack Cocaine within 1,000 ft. of a School.

Freddie Patterson was arrested and charged with three counts of sale & Possession of Crack Cocaine within 1,000 ft. of a School

Tracy Dixon was arrested and charged with six counts of sale & Possession of Crack Cocaine within 1,000 ft. of a School.

- 9. On August 3, 2022, a letter was sent to Josephine Dixon Estate via certified mail, return receipt requested and first-class U.S. mail. The letter advised Respondent that(drug activity had been documented at the property and that the activity was being conducted by Jamayn Johnson, Jamar Johnson, Carlton Brye, Freddie Patterson and Tracy Dixon. Kimberly Johnson received the letter and contacted Lieutenant Wannos to coordinate a meeting. A copy of the letter and return receipt is attached hereto as Exhibit "B".
- 10. On August 18, 2022, Kimberly Johnson met with Lieutenant Wannos regarding the nuisance process and need for abatement to the property. (see thumb drive of body cam video of meeting)
- 11. On September 20, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 12. On September 23, 2022, Clearwater Police Department Detectives purchased cocaine from the residence.
- 13. On November 3, 2022, Detectives from the Clearwater Police Department and the Drug Enforcement Agency (DEA) served a search warrant resulting in the seizure of cocaine, MDMA, and drug paraphernalia used in the sale of drugs.

All drugs seized during the execution of the search warrant were tested using field presumptive tests and the results of said presumptive tests were positive for cocaine and MDMA. The drugs were sent to the Pinellas County Forensic Laboratory for further testing.

Jamayn Johnson was arrested and charged with Sale & Possession of Crack Cocaine within 1,000 ft. of a park.

On November 15, 2022, Aaron Ford and several other family members of Josephine Dixon met with Chief Daniel Slaughter to discuss the nuisance abatement activity

and any potential remedy to the drug activity occurring on the property.

All of the above incidents are in violation of Section 20.02(5), Clearwater Code of Ordinances.

RESPONDENTS ARE FURTHER ADVISED THAT ADDITIONAL INCIDENTS, EVIDENCE, OR TESTIMONY MAY BE INTRODUCED AT TIME OF HEARING.

YOU ARE HEREBY NOTIFIED that the above Amended Complaint For Abatement Of Nuisance will be held before the Nuisance Abatement Board of the City of Clearwater on June 7, 2023, 3:00 p.m., in Council Chambers at City Hall, 112 South Osceola Avenue, Clearwater, Florida. Failure to appear <u>WILL</u> result in action being taken in your absence. All hearings will begin at 3:00 p.m. or as soon thereafter as may be called.

AT THE ABOVE SCHEDULED HEARING, YOU WILL HAVE THE OPPORTUNITY TO PRESENT EVIDENCE AND ARGUMENTS ON ALL ISSUES PRESENTED, TO TESTIFY ON YOUR OWN BEHALF, TO CONDUCT CROSS EXAMINATION AND SUBMIT REBUTTAL EVIDENCE, AND TO BE REPRESENTED BY COUNSEL AT YOUR OWN EXPENSE. IF TRANSLATION IS NEEDED FOR YOURSELF OR ANY WITNESS YOU INTEND TO CALL TO TESTIFY ON YOUR BEHALF, YOU ARE HEREBY RESPONSIBLE FOR PROVIDING SAID TRANSLATOR. IF YOU ARE A PERSON WITH A DISIBILITY WHO NEEDS ANY ACCOMMODATION IN ORDER TO PARTICIPATE IN THIS PROCEEDING, PLEASE CONTACT (727)562-4090 (VOICE) WITHIN 48 HOURS OF THE MEETING OR 711 HEARING IMPAIRED.

If any person desires to appeal any decision with respect to the matter considered at the hearing, such person will need a record of the proceedings and, for this purpose, such person may need to ensure that a verbatim record of the proceedings is made which includes the testimony and evidence upon which the appeal is to be based.

Pursuant to Section 893.138, Florida Statutes and Sections 20.01 through 20.04, Clearwater Code of Ordinances, the Nuisance Abatement Board may, after hearing the case and evidence presented, impose sanctions as provided in the above referenced statute and city code sections. Said sanctions include, but are not limited to:

- 1. Imposing remedial measures to reduce or eliminate future nuisance conduct on the Premises.
- 2. Assess fines, investigative costs, costs of bringing the action, and an attorney's fee, which may become a lien against the Premises.

The Board's Order shall expire after one (1) year or such earlier time as stated in the Order. These proceedings are in rem and run with the land.

The Board may, in addition to the relief outlined above, obtain enforcement of its Order pursuant to the procedures contained in Section 120.69, Florida Statutes, or bring a complaint under Florida Statute 60.05, seeking an injunction to abate the public nuisance.



According to Pinellas County Property Appraiser's records this property is owned by you. This letter is to make you aware of undercover investigations regarding the sale of illegal narcotics occurring at this property. An example of activity that has occurred at this property includes the following:

CW22-76118 - On June 1, 2022, Clearwater Police Department detectives purchased cocaine from within the residence.

CW22-76131 - On June 1, 2022, Clearwater Police Department detectives purchased cocaine from within the residence.

CW22-76561 - On June 2, 2022, Clearwater Police Department detectives purchased cocaine from within the residence.

CW22-78662 - On June 6, 2022, detectives from the Clearwater Police Department purchased cocaine from within the residence.

CW22-81923 - On June 13, 2022, Clearwater Police Department detectives purchased cocaine from within the residence.

CW22-85271 - On June 20, 2022, detectives from the Clearwater Police Department purchased cocaine from within the residence.

CW22-96302 - On July 11, 2022, detectives from the Clearwater Police Department served a narcotics search warrant resulting in the seizure of cocaine, MDMA, and drug paraphernalia used in the sale of narcotics.

This letter is to inform you that any type of activity related to the sales and/or possession of illegal narcotics or prostitution could subject your property to the jurisdiction of the city's Nuisance Abatement Board for a determination of whether the property has become a public nuisance. If the board finds that your property has become a public nuisance, you could be subject to fines, investigative costs, attorney's fees — all of which could become a lien against the property — as well as other appropriate sanctions.

There are actions that you, as the property owner, must take to alleviate the issues arising from this property. Failure to act could ultimately lead to your property being closed by the Nuisance Abatement Board or to the filing of a foreclosure action by the City of Clearwater against your property to recover any liens resulting from orders imposed by the Nuisance Abatement Board.

It is imperative that you contact Lieutenant Stephen Wannos at (727) 562-4142 within ten days of the receipt of this letter to arrange a meeting with him. He will provide you with information and suggestions and will make recommendations in an attempt to assist you in taking positive steps to help alleviate the issues and to ensure that illegal narcotic/prostitution activity does not reoccur on the property.

Within thirty days from the date of this letter, you must submit a written plan of action to Lieutenant Wannos outlining the measures that you are taking to prevent illegal narcotic/prostitution activity from occurring in the future. Please give your immediate attention to this matter to avoid incurring the sanctions mentioned in this letter.

If you are unable to contact Lieutenant Wannos within ten days, then you may speak with his supervisor, Major Nathan Burnside at (727) 562-4160.
