The Board was created pursuant to 893.138(4), F.S. for the purpose of hearing complaints regarding nuisances as described in 893.138(2) and (3), F.S. The Board provides an efficient means of enforcing crimes related to drugs, prostitution, stolen property, and gang activity by imposing penalties on the owners of property at which repeated violations of these crimes occur. Punitive decisions are a last resort. The Police and City Attorney are more effective in resolving repeated violations by virtue of the Board's existence.
