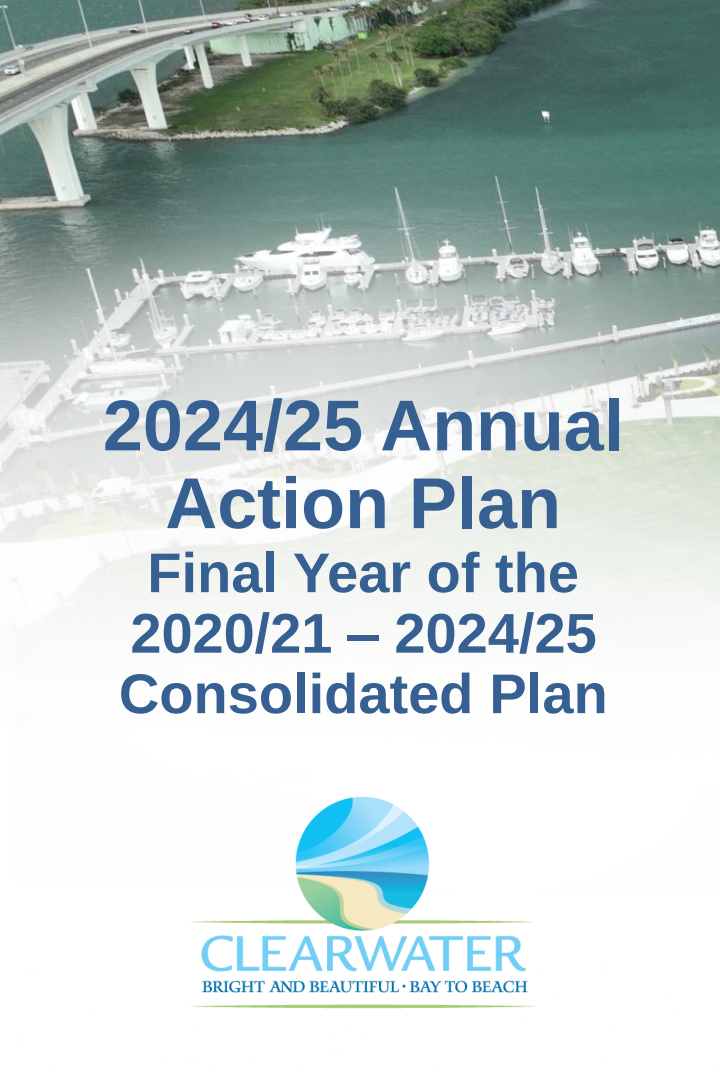

August 16 – Deadline for submittal to HUD

October 1 – Program year begins

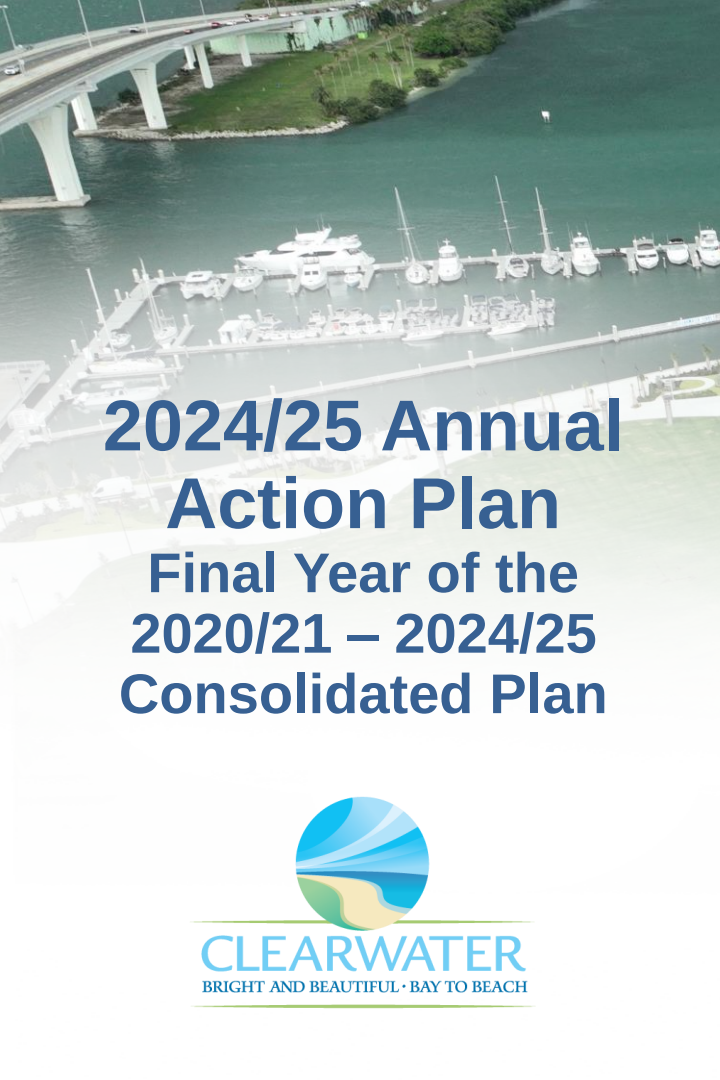
