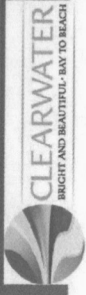

Relevant Work Experience	<p>Lead on Federal fishery management plans, exempted fishing permits, and implementation teams, that have jurisdiction across two fishery management regions, involve two different Fishery Management Councils and multiple Advisory Panels. These are complicated, lengthy projects involving multiple inter-disciplinary divisions, multiple stakeholders, and affect fisheries management in federal waters off nine states. These meetings are attended by attorneys, economists, social scientists, biologists, project managers, and law enforcement officers. Often, these meetings deal with controversial topics and conflicting personalities and require a calm, professional attitude. My job also requires building and fostering effective collaborative partnerships with constituents including within division, across offices, the public, industries, Federal, state, territorial, and/or local agencies. I regularly review and prepare environmental assessments, correspondence, decision memos, reports, and various writing material. Lastly, I participated on a planning committee for 550+ attendee Reef Futures conference including being lead for organizing all plenary sessions, served as co-chair for development and growth of the global Coral Restoration Consortium, and worked with multiple partners to identify and develop information for management to ensure the effective use of resources for the best available scientific knowledge used in decision-making. I believe this experience will translate well into Airpark Advisory Board duties.</p>
Community Activities	<p>Instrumental in initiating the approval of an ex-officio member of the Airpark Advisory Board by working with the City of Clearwater Marine and Aviation Director. For the past 9-months, I have attended the Airpark Board meetings providing public comment on Airpark developments. I plan to move forward by continuing collaboration to initiate the removal of the requirement to be a resident of the City of Clearwater to be on the Board as the Airpark has users from all over and outside of Pinellas County. I am an active leader in the aviation community including attending multiple STEM events with the NOAA Hurricane Hunters, the Ninety-Nines International Organization of Women Pilots (99s), volunteering with Turtles Fly Too, and EAA. I now hold the position of Vice-Chair in my 99s Chapter and work on many of our committees.
