Chair Robinson noted that a request was made to amend the North Greenwood CAC meeting agendas moving forward to have the CRA Director's Report amended to CRA Updates. Jesus Nino, CRA Executive Director commented that this change would allow for staff to provide updates about the CRA to the committee.

## 4.1 ID#25-0476 Discuss St. Petersburg College (SPC) and City of Clearwater partnership to bring pilot Management Consulting service Project to the North Greenwood CRA

Jesus Nino, CRA Executive Director informed the committee about the partnership with SPC and the Clearwater Urban Leadership Coalition (CULC). Fall Semester to bring students to Dr. Rojas that would provide consulting services. Dr. Rojas and his group of students would work with the CULC to analyze their organization, financials, board, programs. Then provide recommendations on how to bring them to the next level. After the 8 week program CULC will be provided a recommendation in a value of \$50,000. Gloria Campbell spoke about the students being able to help with business in the container village. Gloria stated that the students would help CULC bring in business tenants for the container village, market the site, and provide new ideas for the project. When complete there will be a presentation before the City Council.

Chair Robinson asked Jesus Nino if this partnership with SPC is a long-term partnership that could partnership with other nonprofits. Vice Chair Turman said that she is looking forward to working with SPC. Member McKenny voiced his support and asked about future partnerships between SPC and North Greenwood businesses. Member Nun-Crawford if SPC does expand would like for the Willa Carson Center to be considered.

**4.2 ID#25-0478 Expansion of the Business Spotlight Program to Include North Greenwood**Julia Baltas, CRA Specialist, presented to the committee the expansion of the Business Spotlight
Program to include the North Greenwood CRA. She discussed the impact the program had on
businesses in the Downtown Clearwater CRA and mentioned the expansion would broaden to include
North Greenwood CRA boundaries and also legacy business spotlight that would spotlight well
established businesses located in the community. Chair Robinson asked questions about the application
process and where to go to apply. Ms. Baltas shared that applicants can apply online or hand delivering
an application to our office. Member McKenny asked if non-profits could apply. Vickie Shire, CRA
Division Manager, said no it is only applicable for profit businesses and shared information regarding the
marketing plan for this program. Member Truman voiced their support for this initiative.

#### 5.CRA Updates

Brian Ulbricht, CRA Specialist, informs the CAC that he will begin office hours for North Greenwood Community ARPA Grant recipients to assist in tracking expenditures and the grant closure process. Jesus Nino, CRA Executive Director provided a legislative update regarding the future of CRAs. CRA Executive Director also provided an update on Big Jim's BBQ commercial grant and meeting with Mid-Florida Credit Union for community partnerships. Jesus informed the committee that the container village project is before the CRA Board of Trustees for approval. Will provide update on increment for North Greenwood will be provided at next meeting. CRA staff is continuing to puh information on the Commercial and Residential Grant. Member Turman thanked CRA Staff for distributing information to the community. Member Nunn-Crawford asked Brian Ulbricht if a final report is part of the close out process. Brian Ulbricht affirmed that the final report will be part of the closeout.

Kat, a member of the public, asked for opportunities for business owners to help each other and provide mentorship. Chair Robinson allowed Jesus Nino to respond, Jesus informed Kat that he will reach out to business owners.

Member Voilton asked Kat what her purpose was to connect with other businesses. Kat affirmed this.

Jesus Nino, CRA Executive Director remained the CAC to continue with the meeting agenda. The Chair Robinson affirmed this.
