

The community garden on Dempsey has attracted so many homeless people begging for handouts, trespassing, and scaring her ② as they approach her car drunk or high, ringing her door bell or cutting through her backyard. Police cars are now often on this quiet street due to this. The surgence of homeless may be due to handouts of money by the owner of the commercial property. They collect their money, and then camp out. They dump their trash, debris on piles that stay there for months as they do not pay for waste removal. There's a porta potty on the property which adds to the stretch.

Daily, I try to make myself visible in hopes to deter their trespassing and harassment of my mom.



I am sending this email to object to this parcel being approved to build a detached structure. This is a commercially zoned property therefore anything built on it should be a commercial grade and for commercial use to raise the property value of the neighborhood.

As a home owner and mother on Dempsey Street, I am outraged and vehemently concerned regarding the behavior and actions of the people associated with the property at 848 Dempsey Street. I or my husband have found them trespassing on our property, disrespecting our rights as property owners. This happens constantly and are often too drunk, high, or in some other way inebriated to understand and leave. Since their arrival to the neighborhood, there has been an increase of homeless individuals roaming and loitering around my home. This is a serious concern to me as a young woman with young children. I have also seen them sleeping or setting up to sleep on nearby private properties, violating the safety of our neighbors and the surrounding community. These are but few disturbances where this group, who is asking to build a domestic dwelling across from my own house, have disrespected, violated, or harassed the property owners of my neighborhood.

This neighborhood is where my husband grew up, where it was safe to play in the front yard without being worried if some vagrant was going to ask if you for handouts while under the influence of some narcotic or alcohol. I am personally terrified of what the neighborhood would become if this group was allowed to stay permanently. I worry that my own kids will not have the same opportunities to enjoy their childhood. Even I, a fully capable adult, am weary to get the mail, take out the trash, or grab something from my car after sundown. My husband's poor grandmother, who is quite elderly and lives alone on Dempsey Street, has been approached and harassed by these individuals at her own home. I am growing uncomfortable with my own neighborhood for my own family as well as the families around me. When my and my family's safety is at such risk, I cannot just sit and watch while integrity of my community is brought down to this level of degradation.

I am extremely concerned about the goings on of this property that have bled onto my residence. Including but not limited to; numerous trespassing, (more than once when I confronted them about finding people on my property, I was told "just ignore him, he's on drugs"). an increasing amount of homeless people roaming the street, setting up and sleeping on private property, continual shouting matches, actually physical confrontation, etc. One of them even stabbed another. This was once a quiet and safe neighborhood. now it is not uncommon to find homeless high on drugs or drunk. It has brought down the safety of the neighborhood I do not feel comfortable for my infant daughter and pregnant wife. Not to mention my elderly grandmother who lives next door, who has been made to feel unsafe as a result of so many people showing up for handouts and then deciding to stay.

In addition they piled up trash and lawn trimmings at the road, which does not get removed by the city and recently they put it on my property to get picked up.

Previously the city denied a family just one plot over when then wanted to rebuild after a fire took thier house. These were upstanding people and ideal neighbors, but rules were rules. So I see no reason why an exemption should be made for people actively making my neighborhood less pleasant and less sefe.
