Renewal of Software Support Agreement

TriTech Support Services Renewal Agreement Amendment

Except as modified herein, all other terms and conditions of the Software Support Agreement shall remain in full force and effect. With respect to the content herein, in the event of any conflict between this Software Support Renewal Agreement Amendment and the Software Support Agreement, the terms of this Software Support Renewal Agreement Amendment shall control. **This Renewal of Software Support Agreement Amendment and applicable support fees must be signed, paid and returned** by October 1, 2021 to avoid any interruptions in the software support and maintenance services provided by TriTech. Payment of \$198,451.06 is due by October 1, 2021.

Consumer Price Index Adjustment

For support renewals that go into effect within calendar year 2021, the support renewal fees were increased by the currently consumer price index (CPI) rate at the time of invoicing. This current CPI rate was greater than our standard annual increase rate of 5%; therefore the 2021 support renewal fees increase was capped at 5%.


