We are pleased to announce Axon Enterprise, Inc.'s (Axon) acquisition of Fusus on January 31, 2024. For all existing Fusus customers, Axon will assume the contractual obligations set forth in Fusus agreements executed prior to the acquisition date. For new or renewal agreements between Fusus and customers after the acquisition date, Axon will honor these contractual agreements, and may execute upon these agreements via Axon's systems, depending on their date.

Beginning April 1, 2024, all purchases of Fusus products or services (both new or renewal agreements) will be between customers and Axon.
