The meeting started at 9:02 am and ended at 11:00 am.

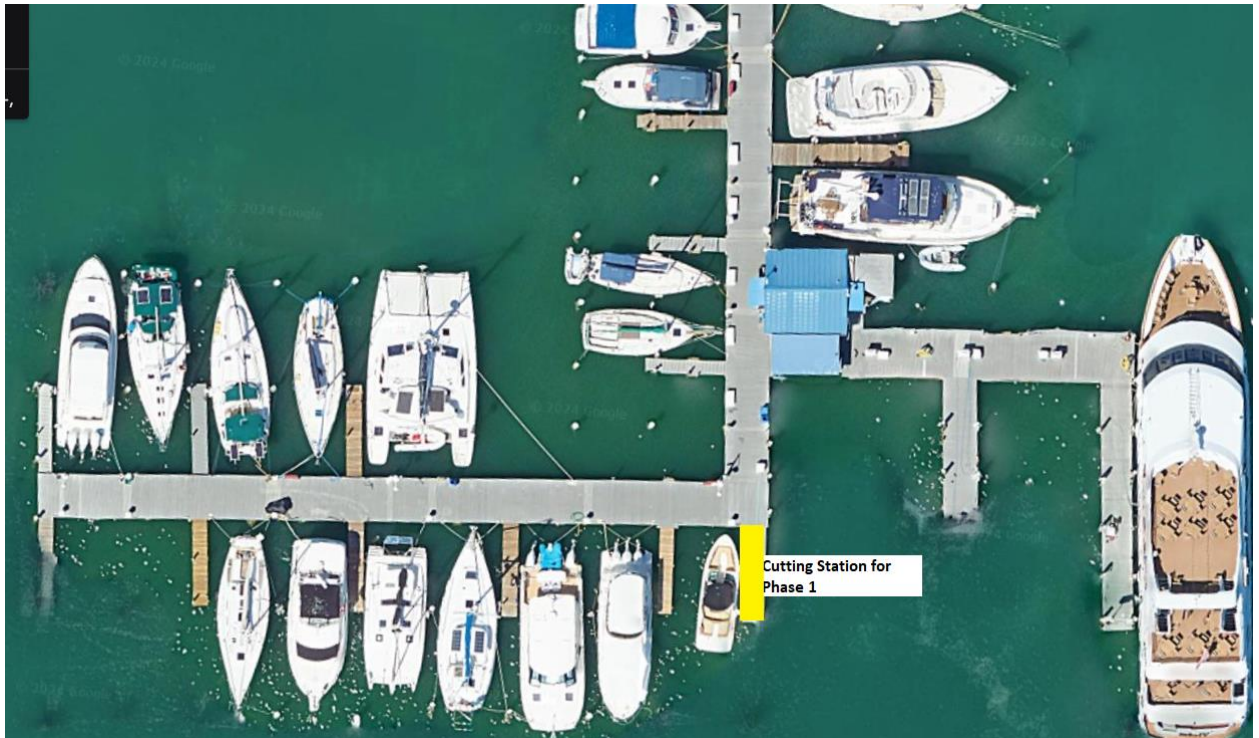
The spokesperson of the Outreach group is Trisha Rodriguez, and the alternative is Chad Haggart.

1. OLE was contacted by Michael Colby, who verified that fishing vessels can prepare fish on their vessels instead of having to do it on a cutting board off the boat. FWC representatives will have to board the vessel to conduct inspections. Per regulations, the craft needs to be docked. The group concluded to have a communal fish cutting station next to the Fuel Dock.
2. A secondary cutting station will be made on the West end of the fuel dock to assist vessels needing more room.



3. The City of Clearwater will see what can be done to minimize congestion within the Causeway parking area by communicating with the construction company and seeing if they can also utilize the Ferry and Trolley services.
4. The Harbormaster will see what cost is involved with the Causeway parking.
5. The Outreach Group will contact neighboring hotels to see if they can utilize parking within their garages. Spokesperson, Trish, is working with City Management on a Jolly Trolley and/or Marine Ferry option for additional funding. It was discussed that the tenants would have to pay for the service if there is no available funding from the City.
6. The Harbormaster will work with the contractor to see if we can locate a better location for the dredging equipment.

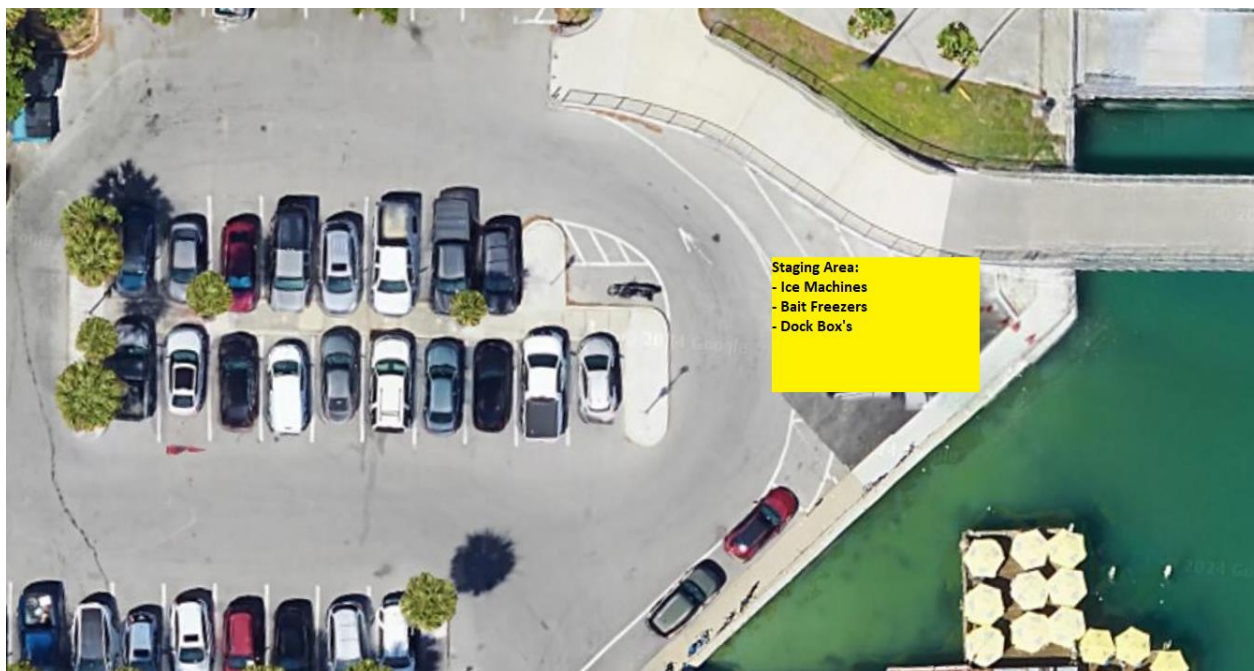




9. The Marine and Aviation Department will contact everyone in the Phase 1 temporary relocation move to see kiosk plans and maximize the area allocated in front of the Starlight Majesty. Marine and Aviation will develop an area for Phase 1 tenants to have a set up area. We will need the tenants wanting an area to come into the office and let us know the size of the area that they

need along with the power demands (amps of equipment needing to operate). This is needed no later than July 1<sup>st</sup>.

10. Staging Area - Harbormaster will contact Jeff to see what electrical and water availability there will be in the area just North of the Bait House to see if we can stage Temporary storage, ice machines, and bait freezers—freeing the Kiosk location on the Southside of the parking lot in front of the Starlight Majesty.





11. Railing Option the City of Clearwater will provide extra protection down the main dock leading to the vessels. Behind each vessel, there will be an accessible location that suits the tenant's needs.

12. The operators that have their boats in lifts will not be able to move their lift as it would require permitting which each temporary slip already has designated permitting.
13. All operators are asked to give Bill your piling configuration request no later than July 1<sup>st</sup>.
14. Trisha Rodriguez will check the Facebook page to make sure the Committee members can be administrators to post accordingly, and the public can make comments.
15. Members discussed the desire to have public be able to walk the East Dock and how we could work together for safe boarding on a busy dock while also allowing public to walk on the dock.
16. The City is looking into moving cameras or adding additional cameras for increased security at the temporary slips.
