

# Why Do Cavities Matter?

- Infection
- Extreme pain
- Difficulty in chewing
- Poor weight gain
- <u>Difficulty concentrating</u>
- Missed school hours
- Predictor of cavities in later life
- Costly treatment
- LIFE THREATENING
- DEATH





Deamonte Driver, 12, died February 25, 2007, after an infection from a molar spread to his brain



## **CAVITIES:** Disproportionately Distributed





- Nearly 80% of cavities occur in 20% of the population
- The poor bear a disproportionate burden of cavities



# Community Water Fluoridation An Ounce of Prevention:

#### After 71 years of CWF in the United States, the FACTS:

- 1. Safe-NO adverse health effects in anyone
- 2. Effective-Adults & Children benefit: 25% reductions in cavities
- **3. Cost Savings-**Saves millions of dollars in treatment costs and eliminates preventable pain and suffering. Huge Return on Investment: \$1:\$43
- 4. CDC: One of 10 great Public Health Achievements of the 20th century
- **5.** Americans keep their teeth longer into adulthood more than ever before
- 6. >214 million U.S. residents served by it daily (2014), ~75% of Community Water Systems
- 7. Community Water Fluoridation is closest thing we have to a Magic Bullet


# History of Fluoride's Benefits

#### Frederick S. McKay



1901 – established practice in Colorado Springs, CO

- Curious mind and good observational skills
- "Colorado Brown Stain"



- ➤Only life-long residents (or those who had moved there as infants) had stain
- 1908 began to investigate extent of condition in surrounding area



**Key Observation**: very few cavities in this population





# H. Trendley Dean

- 1931 First dentist appointed to the National Institute of Health
- Primary responsibility -investigate the association between fluoride and mottled enamel
- Mid 1930's Dean began to use the term fluorosis in place of mottled enamel
- Determined that fluorosis caused by water with 1.0 ppm or less was of "no public health significance"





### **Community Water Fluoridation Begins**



- Grand Rapids, Michigan was the first city to adjust fluoride concentration in public drinking water (1945)
- Cavity rates dropped dramatically
- Gainesville 1<sup>st</sup> city in Florida to fluoridate
   -1949
- The rest is History
- 2016 marked the 71<sup>st</sup> anniversary of community water fluoridation



# Dental Fluorosis: What is it?



- Dental fluorosis is a change in the appearance of the tooth's enamel.
- Very mild and mild forms of dental fluorosis (the most common forms)—teeth have scattered white flecks, occasional white spots, frosty edges, or fine, lacy chalk-like lines. These changes are barely noticeable and difficult to see except by a dental health care professional.
- Moderate form—teeth have larger white spots
- The rare, severe form—rough, pitted surfaces.
- Dental fluorosis **only occurs** when younger children (<8y.o.) consume too much fluoride while teeth are developing under the gums






# What is Fluoridation? Is it Still Necessary?



#### Fluoride is Naturally Occurring

- 13<sup>th</sup> most abundant mineral in the earth's crust
- Surface water (rivers) -- typically low concentrations, 0.2 mg/L (ppm) or less
- Clearwater has 0.2 mg/L naturally
- Groundwater (wells) --higher concentrations, 0.1 mg/L to over 5.0 mg/L
- Ocean water is typically 0.8 to 1.4 mg/L





# **Fluoridation Definition**

- Fluoridation is the <u>precise adjustment</u> of the fluoride in drinking water to a level that is recommended for optimal reduction of tooth decay
- This adjustment includes adjustment <u>upwards or</u> <u>downwards</u>, depending on the natural level of fluoride in the water.




 Updated optimal level for community water fluoridation is a uniform 0.7mg/L (ppm)



# **Required for Cavities:**

#### Diet

- sugars and carbohydrates
- frequency of intake
- •form of substrate-sticky vs nonsticky
- Oral hygiene
  - •Toothbrushing, flossing, fluoride toothpaste & mouthrinses
- •Xerostomia (Dry Mouth)
  - drug induced
  - radiation therapy
  - salivary flow and composition
- Bacteria Levels
  - (especially mutans streptococci)

## Is Water Fluoridation Still Necessary?







- ✓ Effect of Starting Community Water Fluoridation:29.1% cavity reduction
  - ✓ New South Wales, Australia
- ✓ Effect from Stopping CWF: 17.9% increase in cavities
  - ✓ Calgary, Ontario Canada-stopped 2011



# **How Does Fluoride Work?**




### Summary of Mechanisms of Action of Fluoride Ion

- Predominant Effect is post-eruptive and topical:
  - ✓ Fluoride coming in contact with the teeth after eruption
  - ✓ Toothpaste, rinses, varnish, saliva

#### SYSTEMIC EFFECT:

- ✓ Best when small amounts maintained constantly in the mouth, specifically in <u>dental plaque</u> and <u>saliva</u>
- ✓ Fluoride becomes incorporated into developing permanent teeth of children while still under gums-more resistant to cavities
- Adults also benefit from fluoride, rather than only children, as was previously assumed







# The Science Is there a Debate?

Debates on the science of any topic takes place in expert panels that have been set up to critically evaluate the literature, never in public forums



#### **CWF--THERE IS NO DEBATE!!**

#### Safe: No adverse health effects from drinking fluoridated water

#### **Effective:**

- ✓ Reduces cavities by at least 25% over a person's lifetime by simply drinking the water. Does not require a cognizant change in behavior
- ✓ Benefits all members of the community, regardless of age, race, ethnicity, SES, or access to dental care

#### **Cost Savings:**

- ✓ The most Cost Efficient & Cost Effective means to reach everyone in the community with the cavity fighting benefits of fluoride.
- ✓ Offers a great ROI: For every \$1 invested in fluoridation, \$43 in dental treatment costs/person/year are avoided

<u>Pain/Tooth loss</u>: Reduces needless pain & suffering from preventable cavities, and tooth loss from extensive destruction of the tooth

#### **Community Preventive Services Taskforce**



(Note: studies used were evaluated by the Cochrane Oral Health Group)

#### **Recommendations Reaffirmed 2013:**

- 1. Community Water Fluoridation is **RECOMMENDED** based on **STRONG EVIDENCE** of effectiveness in **reducing cavities across populations**
- 2. Evidence shows the **prevalence of** *cavities* is *substantially lower* in communities with community water fluoridation (CWF)
- 3. There is **NO EVIDENCE** that CWF results in **severe fluorosis**





# FLUORIDE IN DRINKING WATER A SCIENTIFIC REVIEW OF EPA'S STANDARDS

Report issued in March 2006:

**MCLG:** Maximum Contaminant Level Goal: is a health goal set at a concentration at which NO ADVERSE HEALTH EFFECTS are expected to occur and the margins of safety are judged "adequate."



#### MCLG for Fluoride is 4mg/L

~200,000 people



#### **Summary of Findings:**

MCLG for Fluoride at 4mg/L: *ONLY* health effect is *severe fluorosis* 



Severe fluorosis is *virtually zero* at 2mg/L (ppm) fluoride in water





#### **NOTE:**

- Community water fluoridation = 0.7ppm (mg/L)
- 1/3<sup>rd</sup> level at which severe fluorosis is virtually zero




# Claims by Opponents: <u>ALL FALSE</u>


#### **FACTS:**

Mild

- There are no known adverse health effects for infants
- Milder form of dental fluorosis is the only risk
- **Vitamin D** is added to milk because mother's milk **lacks** sufficient amounts. The National Academy of Sciences and the American Academy of Pediatrics recommends vitamin D per day beginning during the first 2 months of life
- **Vitamin K**-injection given to infants-deficient
- *Iron* supplementation given to infants to prevent anemiadeficient



## In Response to Paul Connett's Claims of THYROID PROBLEMS in Brooksville, FL

Dr. Janet Silverstein currently serves as Program Director for the Pediatric Endocrine Fellowship at Shands at UF and Division Chief of Pediatric Endocrinology at UF. In her To Whom It May Concern:

As a practicing endocrinologist, I was appalled at the claims that fluoridated drinking water causes clinically significant harm to the endocrine system.

Clinically, in more than 30 years of seeing patients, I have never seen any fractures or thyroid problems associated with fluoridated water. Early puberty is more associated with obesity than anything else, though there are many endocrine disrupters that have estrogenic effect. Fluoride has not been implicated, though lavender, tea tree oil and HCG, substances found commonly in hair products, have been.




Figure 1. Source: Data from the World Health Organization database. Available at <a href="http://www.mah.se/CAPP/Country-Oral-Health-Profiles/">http://www.mah.se/CAPP/Country-Oral-Health-Profiles/</a>; Figure 2: Source: Cheng, KK, Chalmers, I, Sheldon, TA. Adding Fluoride to water supplies. *BMJ*; 2007;335(7622):699-702.






Figure 3: Data from the World Health Organization database. Available at http://www.mah.se/CAPP/Country-Oral-Health-Profiles.



#### Claim: Fluoride causes Osteosarcoma

**FACTS:** There has been *no causal relationship* of fluoride, *at any level*, demonstrated to be associated with cancers:

#### Claim: Don't use CWF with Infant Formula

#### **FACTS:**

This has NEVER been accurate!!!

#### **ADA recommendations:**

 Continued use of liquid or powdered concentrate infant formulas reconstituted with optimally fluoridated drinking water while being cognizant of the potential risk for *mild* enamel fluorosis



Mild

 Use ready-to-feed formula or liquid or powdered concentrate formula reconstituted with water that is either fluoride-free or has low concentrations of fluoride when the potential risk for *mild* enamel fluorosis may be a concern

for parents



#### Claim: Toothpaste contains fluoride poison

#### **FACTS:**

Warnings Keep out of the reach of children under 6 years of age. If more than used for right away. Ask a dentist before use if you have • bleeding or redness lasting more than 2 weeks • pain, swelling, pus, loose teeth, or more spacing between teeth. These may be signs of periodontitis, a serious form of gum disease.

• Adults and children 6 years of age and older: Brush teeth thoroughly, preferably after each meal or at least twice a day, or as directed by a dentist or a physician. • Children under 12 years: Instruct in good brushing and rinsing habits (to minimize swallowing).

"To this day, according to the American Association of Poison Control Centers, there have not been **any** deaths or serious adverse reactions from ingestion of fluoride toothpastes"

- ·Same labeling on vitamins, Tylenol-required: by FDA



#### **FACTS:** No one has ever died from toothpaste ingestion



#### Responsible Parenting!!

- It would take a 20kg child (~4 year old) ingesting <u>2 full tubes</u> of Adult sized toothpaste <u>at one setting</u> to reach a lethal dose of fluoride
- The sudsing agent and abrasive components of toothpaste would cause anyone ingesting excess toothpaste to throw up.



#### **Claim:** Mass Medication

#### **FACTS**:

- U.S. courts have <u>rejected</u> the idea that fluoride is a medication and should not be allowed in water supply
- **Fluoridation**: the adjustment of *natural* (background) water fluoride levels to bring to optimum.
- Fortification is a common practice Folic acid, Vitamin D, lodine etc.


