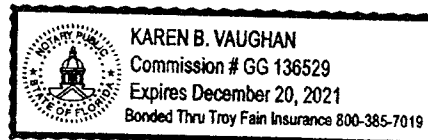

You are hereby formally notified that on **Wednesday, January 20, 2020**, at **1:00 p.m.** there will be a public hearing before the Special Magistrate in the ~~Council Chambers~~, Clearwater Main Library at 100 North Osceola Avenue, Clearwater, Florida, concerning violation of Section(s) **33.055** of the Clearwater City Code. You are hereby ordered to appear before the Special Magistrate on the hearing date to answer these charges and to present your side of the case. Please be prepared to present evidence at the hearing concerning the amount of time necessary to correct the alleged violations should you be found to be in violation of the City Code.

The case shall be presented to the Special Magistrate even if the violations described in the attached Civil Citation are corrected prior to the appeal hearing.

Should you be found in violation of the City Code, the Special Magistrate has the power by law enter an order assessing a fine and all costs of towing and storing against you. Additionally, as provided in section 705.103(4), Florida Statutes, a person who neglects or refuses to pay such costs may not be issued a certificate of registration for such vessel or for any other vessel or motor vehicle until such costs have been paid.

If you have any questions regarding the cited violations or if the violations are corrected prior to the hearing, please contact the Officer whose name appears on Civil Citation.

NOTICE TO THE OWNER AND ALL PERSONS INTERESTED IN THE PROPERTY (VESSEL) DESCRIBED HEREIN. The following property (vessel), to wit: 32' white with red strip sail boat named "Aries II", is unlawfully upon public property known as 45 Causeway Blvd (Waterway East of) and must be removed within 5 days; otherwise, it will be removed and disposed of pursuant to chapter 705, Florida Statutes. The owner will be liable for the costs of removal, storage, and publication of notice.

You have been identified as the last known owner or responsible party for the above described vessel, which the undersigned law enforcement officer of the Clearwater Police Department (CPD) has determined to be derelict as defined in section 823.11, Florida Statutes, which is a violation of City of Clearwater Code of Ordinances section 33.055.

The facts upon which CPD has made the determination that the vessel described above is derelict are as follows:

NARRATIVE: (vessel discovery, owner information, reasonable cause, etc.)

On 11/12/2020 Officer McMullen and Officer Perz observed a vessel, known to them as the Aries II, washed ashore in the mangroves just east of 45 Causeway Blvd. The vessel appeared to have broken free of its anchorage during Tropical Storm Eta.

The vessel's keel is dug deep into the sea floor and unable to be moved. Howard Toller has been identified as the owner and responsible for this vessel. On 12/03/2020 Officer McMullen placed a five day removal sticker on the vessel.

On the same day Officer McMullen hand delivered a derelict vessel letter to Howard Toller at his residence. Toller advised that he is working with Sea Tow to remove the vessel and has made arrangements for removal on 12/10/2020.

City of Clearwater Code of Ordinances section 33.055, along with sections 376.15 and 823.11, Florida Statutes, make it unlawful for any person, firm, or corporation to store, leave, or abandon any derelict vessel on the public waters of the State.

Subsection 705.101(3), Florida Statutes, defines all derelict vessels as abandoned property. Sections 376.15, 705.103, and 823.11, Florida Statutes, authorize law enforcement to remove or cause to be removed any derelict vessel from the public waters of the State and to destroy it. All costs incurred by law enforcement or authorized agents in the removal of the derelict vessel are recoverable against the owner or responsible party thereof.

In accordance with the above legislative mandate, CPD hereby orders you as the last known owner or party responsible for this vessel to remove it from the public waters of the State immediately or to provide proof that legal transfer of the vessel's ownership occurred prior to the date of this notice. Failure to do so will result in a hearing before a special magistrate pursuant to article 7 of the Clearwater Community Development Code, notice of hearing attached, at which hearing the City will seek to adjudicate a violation of City of Clearwater Code of Ordinances section 33.055. If the vessel is not removed from the public waters of the State, and you are found guilty of violating section 33.055, CPD intends to remove or cause the removal of this derelict vessel (if it has not already been removed), and the vessel will be destroyed.

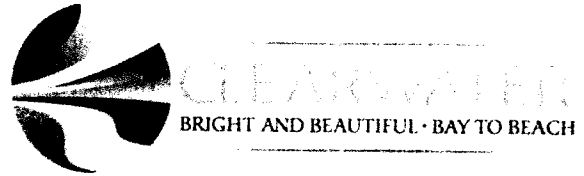

You have been identified as the last known legal owner or custodian of a 1978 32' sailboat, named Aries II with HIN ENC323630678. This vessel is an abandoned or derelict vessel located east of 45 Causeway Blvd, Clearwater, FL on the south side of SR 60 in Pinellas County.

Sections 376.15 and 823.11, Florida Statutes, makes it unlawful for any person, firm, or corporation, to store, leave or abandon any vessel defined as derelict. Derelict is defined as in a wrecked, junked, or substantially dismantled condition upon any public waters of this state; or at any port in this state without the consent of the agency having jurisdiction thereof or docked or grounded at or beached upon the property of another without the consent of the owner of the property.

The Clearwater Police Department is authorized and empowered under state law, to remove or cause to be removed any abandoned or derelict vessel from public waters in any instance when the same obstructs or threatens to obstruct navigation or in any way constitutes a danger to the environment. All costs incurred by our agency or its authorized agents in the removal of any abandoned or derelict vessel shall be recoverable against the owner/ custodian thereof.

In accordance with the above legislative mandate, The Clearwater Police Department hereby orders the last known legal owner/custodian of any abandoned or derelict vessel to remove the vessel from public waters within five days of receipt of this letter. Failure to remove the vessel may result in a civil and/or criminal penalty, pursuant to sections 376.15 and 823.11, Florida Statutes, and/or the removal of the vessel by the state at the owner's expense.

Narrative

SYNOPSIS OF EVENT:

On 11/12/2020 at approximately 1700 hrs I observed a 32 foot sail boat that had run aground into the mangroves in the waterway just east of 45 Causeway Blvd on the south side of SR 60. The owner has been identified as HOWARD TOLLER and a derelict vessel investigation has been initiated.

INVESTIGATIVE ACTION TAKEN:

Officer Perz and I were on patrol in the Clearwater Police Department fully marked police boat assessing the damage caused by Tropical Storm Eta that made landfall late in the evening on 11/11/2020. We arrived in the area just east of 45 Causeway Blvd and observed a 32 foot sailboat that had pulled anchor and drifted into the mangroves extremely close to shore. It appeared that the keel of the vessel was deep into the mud and was actually holding the boat up right. There was little to no water around the boat. The boat was in an area that was too shallow to approach from the water and the mangroves were too thick to approach from land. With this said we were unable to sticker the vessel for removal. From prior dealings with this vessel I knew it to be the "Aries II."

A few weeks prior to this incident, 10/19/2020, there were occupants living on the vessel and it broke free of its anchor and drifted to the Clearwater Beach Marina. Officer Capogna made contact with the occupant, Thomas Oglesby, and the admitted owner, HOWARD TOLLER. Please see his report for further details, CW20-138601. Since this incident, it was learned that Oglesby had vacated the vessel and it has been vacant.

With all of the above information a derelict vessel investigation has been started. Contact will be made with TOLLER and charges will be forwarded to the State Attorneys Office at a later date.

This case will remain open and any further action will be supplemented under this report number.
