29.30(3) - **BUSINESS TAX REGISTRATION** Any person who does not maintain a permanent business location or branch office within the city, but desires to transact a business within the city shall register with the city manager the business tax receipt of that municipality or other governmental subdivision in which they maintain a permanent business location, or if no business tax is required by the other municipality, a registration of the business shall be required, unless otherwise provided by this article. Such registration shall be accomplished prior to the commencement of the business, shall be subject to a registration fee as prescribed in appendix A to this code and shall be valid from the date of issuance to the next succeeding September 30.

29.30(7) - **DISPLAY OF BUSINESS TAX RECEIPT REQUIRED** Each business shall display the business tax receipt in a prominent location within the individual business location. Each registered business shall have the business tax receipt or a copy of the business tax receipt in/on possession of the business representative while conducting business within the city.

This shall result in a fine to run daily until the violator notifies the Code Compliance Division. After notification from the violator, the inspector will complete an inspection to determine compliance and the fine shall cease upon the date of the inspection in which compliance is achieved.
